**MEMORANDUM OF ASSOCIATION,
OF
RAJA SAHIB EDUCATIONAL SOCIETY,
VPO: JHINGRAN, TEH. & DISTT. NAWANSHAHR.**

1. NAME:

The name of the society is Raja Sahib Educational Society, here-in-after referred to as "Society".

2. REGISTERED OFFICE:

The Registered office of the Society is in the state of Punjab at Village & Post Office Jhingran, Teh & Distt. Nawanshahr.

3. AIMS AND OBJECTS:

The main aims & objects of the said Society shall include several aims & objects as per below:-

- a) To lookafter and manage the affairs of Raja Sahib Public School, VPO: Jhingran, Teh & Distt. Nawanshahr Doaba.
- b) To make arrangement for the upliftment & development of Raja Sahib Public School, VPO: Jhingran, Teh & Distt. Nawanshahr Doaba.
- c) To ensure & encourage the study of Science, Medicine, Commerce, Fine Arts, Computer Science and other Indian Languages etc.
- d) To make arrangements for providing the Students of the School with various exams conducted by Punjab School Education Board.
- e) To organise seminars, educatory programmes for the general development of the students of this school.
- f) To provide means for giving Technical Education as far as it is consistant with the first object.
- g) To nominate the members for teaching and training programmes that shall be instrumental in the training and development of the students of the school.
- h) To built School's own Building, Library, Science Laborateries and Play Grounds. As also to establish branches of the School at anyother place(s) within the State of Punjab.
- i) To get the School recognised/affililated with Punjab School Education Board, Mohali.
- j) To appoint staff for the School, to fix their salaries & allowances and to take proper action against the negligent and inefficient staff of the School, even to dismiss such staff members.
- k) To manage the affairs of Raja Sahib Public School, VPO: Jhingran in regard with administrative, financial matters such as to raise funds for School and to utilise the funds for the attainment of the aims and objects of the Society.
- l) To acquire, purchase, take on lease or otherwise acquire land building and assets of all discription for the purpose of the Society from individuals, local bodies, Govt. etc and to sell, transfer, exchange demise or otherwise dispose of any property or asset, movable or immovable, in the interest and for the benefit of the Society.
- m) To do all lawful acts, deeds or things such as to forming of sub-committees for specific works, or all such things which are
